# New Water Efficiency Team (WET) needs volunteers

Our Water Conservation Group has been working on a plan to speed up the repairs needed when an irrigation leak or break occurs in our community's many common areas. This plan of establishing a Water Efficiency Team was recently approved by the SC Board of Directors as a new committee.

We will need some people to be WET Liaisons. A WET liaison is a person for residents to contact when they have seen a problem with irrigation in amenity areas, common areas or managed homes areas, where the HOA pays the water bills. The liaison will then log into the HOA service ticketing system to create a ticket so it can be repaired in a timely manner, saving water and money.

WET will be beneficial for many reasons: most of the water waste in Stone Creek comes from landscape irrigation line and sprinkler head breaks, poorly adjusted sprinkler heads, watering in the rain, etc.; and the HOA office (FS Residential) and the landscape contractor (BrightView) are only on site during normal business hours, but common area irrigation run times are generally off hours. Thus, the residents are more likely to notice a problem and could report it in a much timelier manner than the landscape contractor's routine system checks.

### Check Your Irrigation Timer When You 'Fall Back' to Standard Time



Your Water Conservation Group is reminding residents to check the timers on their irrigation system controllers this weekend, which is the end of daylightsaving time (Sunday, Nov. 3). The time change is also a good opportunity to make sure irrigation system timers are set correctly to ensure that the systems operate consistently with year-round water conservation measures. We should now change to watering once a week. If you have difficulty with changing your

#### Water Restrictions as mandated by Marion County

Watering Schedule for November 3, 2024, through March 9, 2025

Irrigation is allowed only before 10 a.m. or after 4 p.m.

Odd numbered address - Saturdays

Even numbered address - Sundays

Why is watering restricted to one day a week in the winter?

Based on scientific analysis from the University of Florida IFAS program, healthy Florida lawns require no more than two days per week of water during the hot, dry season — less during rainy periods — and no more than one day a week during cooler weather. Additional irrigation is unnecessary and wasteful. During the months of December, January and February, turf grass usually goes dormant, so watering every other week will suffice. Why is there a limit? Freshwater is a finite resource in Florida, and landscape irrigation can account for more than 50 percent of total water use at residential locations.
